**Subject:** 2024 South Forestview Area Improvements - Project Update – August 2, 2024

### Residents and Project Stakeholders:

The first layer of pavement was installed on Riverwood Road, Parkview Circle, and Forestview Drive (south of River Vista Drive). Installation of remaining utilities was completed along Maryland Road including watermain, sanitary sewer, and sewer/water service stubs. Soil preparation ahead of sodding and seeding was completed on River Vista Court. Late this week the utility crew completed installation of a storm sewer culvert along the new alignment of Forestview Drive. Grading crews continued shaping ditch bottoms and began topsoil installation on Parkview Circle and Forestview Drive (south of River Vista Drive).

#### Project Schedule/ Upcoming Work:

The Contractor's tentative schedule for upcoming work includes:

- The turf restoration subcontractor is scheduled to continue soil preparation along River Vista Drive and begin placement of sod next week.
- Utility crews will continue to install various utilities along Forestview Drive (north of Medford Road) including watermain, sanitary sewer, and sewer/water service stubs.
- Grading crews will remain on site for a majority of next week completing roadway subgrade preparation and gravel placement along Forestview Drive (south of Medford Road) and Maryland Road.
- The contractor is scheduled next week to begin paving driveway ends along Riverwood Road and Parkview Circle. Several residents have inquired about completing driveway work beyond the project limits. The paving subcontractor on this project is Anderson Brothers. ### 24-hour Emergency Contact:

The deep utility work in the construction zone has created concerns related to the driving surface. If you need assistance related to access or have problems with traversing through the project area, the primary contact from RL Larson Excavating is Terry Kraemer, phone number 320.980.4416. RL Larson will have representatives at the site through weekend periods to maintain the grade and monitor the driving surface.

## Access Limited in Areas of Utility Work:

The deep utility work restricts access for residents throughout the project area. The intent is for vehicles to be able to leave in the early morning, and return in the evening, but access restrictions during the daytime working hours may occur. # Private Utility Interruptions May Occur as Work Continues (Gas, Internet, Power)

There have been interruptions to various utility services after lines were impacted as construction progressed. Residents should be aware that this impact may occur as the underground work is completed. RL Larson and the other Contractors do their best to take care around the private utility lines (gas/internet/power), but the reality is that impacts do occur with this type of work. Please note, if you do have any impacts with your private gas, internet, or power service, please contact your service provider to alert them of the outage or issue.

## Package Deliveries:

Project staff have been in contact with package delivery services, coordinating access to the South Forestview neighborhood. Private delivery services such as UPS, FedEx, DHL, etc. intend to deliver packages as access allows and contact residents to re-schedule delivery if needed. USPS policies do not allow for delivery of mail or packages in construction zones but will deliver mail and packages to temporary mailboxes. In the event that a package is not able to fit inside the temporary mailbox, USPS will provide a notification to pick up the package at the local Post Office.

### Irrigation System Repair:

As topsoil and restoration work is completed throughout the project area, the contractor intends to make all necessary repairs to irrigation systems impacted by construction. If you have not already done so, please notify SEH staff if you notice any damage to existing irrigation systems.

### Work Zones:

Notice on Construction Zone Activities:

Road work signs or other temporary signage will be installed throughout the project areas to warn motorists
and protect workers during construction. Please pay careful attention to the warning signs. Please exercise
caution as you navigate the work zones.
